***Sign-In Sheet & Acknowledgment of User Responsibility, Express Assumption of Risk, and Release of Liability***

**COVID-19 Certification:** By signing this sheet, I represent that, I and each of us listed below do not have COVID-19 and, within the previous fourteen (14) days I/we have not had any illness or symptoms of illness, including but not limited to fever, cough, or shortness of breath. I/we agree that the City may take and record my/our temperature before I/we am/are allowed entry to this facility.

**Assumption of Risk.** Each person signing below fully understands that our use of the EI Centro Athletic Sports Fields exposes us to the risk of personal injury, death communicable diseases, illnesses, viruses, or property damage. Each of us hereby acknowledges that he/she/they voluntarily are participating in the use of City of EI Centro Athletic Sports Fields and in consideration of that use agrees to assume any and all such risks from its use. Each person understands there may not be City Staff or other personnel available for assistance.

**Waiver and Release.** Each of us hereby releases, discharges and agrees not to sue the City of EI Centro or its officers, agents, employees or authorized volunteers for any injury, death or damage to or loss of personal property arising out of, or in connection with use of City of EI Centro Athletic Sports Fields from whatever cause, including the active or passive negligence of those officers, agents, employees or authorized volunteers or of any other users of City of EI Centro Athletic Sports Fields. Each of us understands that this document is not intended to release any party from any act or omission of "gross negligence," as that term is used in applicable case law and/or statutory provision.

**Indemnification:** In consideration for being permitted to use City of EI Centro Athletic Sports Fields, I hereby agree, for myself, my heirs, administrators, executors and assigns, that I shall indemnify and hold harmless the City of EI Centro, its officers, agents, employees and authorized volunteers from any and all claims, demands actions or suits arising out of or in connection with my use of City of EI Centro Athletic Sports Fields.

**Compliance with Regulations.** We have read and will comply with all rules and regulations for use of City of EI Centro Athletic Sports Fields and will pay any and all fees and costs. I understand that I must obey all rules and instructions for use of City of EI Centro Athletic Sports Fields and that failure to do so may lead to expulsion from the facilities.
